

COVID 19 – THE HARD FACTS

The following CANNOT be debunked by fact-checkers...

Let's start at the beginning of this whole coronavirus manipulation.

Coronavirus was **BRANDED** by the US and the UK in 1966. It was one of the first DNA sequences of a virus isolated and selected by the US and the UK in 1966-67 as the first way they could do transatlantic **BIOLOGICAL ENGINEERING** and **BIOLOGICAL WEAPONS** programs. It is published as such.

In 1967, coronavirus was the first pathogen transported across the Atlantic to infect healthy volunteers in the United Kingdom intentionally.

So, for the past 56 years, the US and UK have been playing around with this pathogen model, which has allowed them to develop an enormous number of enterprises around the control and, ultimately, the destination of **POPULATION ENGINEERING**.

It was not until 2002 when Ralph Baric at the University of North Carolina, Chapel Hill, in 1999, received funding for a project where he successfully took the coronavirus pathogen model and **MODIFIED** it to target **HEART TISSUE**.

Read that **CAREFULLY**. People did **NOT** accidentally get myocarditis; they did **NOT** accidentally get heart attacks. It was **ENGINEERED** by Ralph Baric so that the thing that used to infect gastroenteritis or pulmonary cold-like symptoms would **TARGET** the **HEART**.

Let that sink in for a moment ...

In 2002, Ralph Baric received funding from the National Institute for Health (NIH), the National Institute of Allergy and Infectious Diseases (NIAID), and the National Science Foundation (NSF). Ralph Baric then obtained a **PATENT** that was **FILED** in 2002 for an...

“INFECTIOUS REPLICATION DEFECTIVE CLONE.”

The reason why those terms are so critical is because:

INFECTIOUS means it targets tissue in a human being...

REPLICATION DEFECTIVE means that, unlike the traditional viral model, it does NOT pass from one person to the next.

Not surprisingly, when the world was supposed to shut down in 2003 – recall SARS 1.0 when only a few hundred people got sick and died – this giant FEARMONGERING in 2003 when we were supposed to see the world collapse, it didn't because the pathogen as a bioweapon DID work. It actually TARGETED the people it was GIVEN to.

Fast forward to 2012 and 2013, at the Wuhan Institute of Virology, working in combination with the University of North Carolina, Chapel Hill, funded entirely by the NIAID, researchers identified a very particular modification of what was the coronavirus model at the time. They decided to build a SERIES OF PROGRAMS at the University of North Carolina, Chapel Hill, funded under the BIO DEFENSE & BIOWEAPONS PROGRAM.

It's important to point out some simple facts. In 2005, Ralph Baric received funding for:

“BIO HACKING SYNTHETIC CORONAVIRUS BIOWARFARE-ENABLING TECHNOLOGIES.”

That is NOT for public health. It is for biowarfare-enabling technologies.

Go on, check it out, fact-checkers.

In 2012-13, the researchers started to modify this for HIGHER lethality to the point that everything with it was injected into DIED.

It was NOT an experiment to see how harmful it was. It was a **MURDEROUS INTENT**. An INTENT to KILL and an INTENT to HARM. In 2015, quoting from the Proceedings of the National Academy of Sciences (this FACT cannot be debunked by 'paid' fact-checkers):

“Until an infectious disease crisis is real and present, it is often largely ignored that to sustain the funding base beyond the crisis, we need to increase the public’s understanding of the need for medical countermeasures, such as the pan coronavirus vaccine. A key driver is the MEDIA, and the ECONOMICS will follow the HYPE. We need to use that hype to our advantage to get to the real issues. INVESTORS WILL RESPOND IF THEY SEE PROFIT AT THE END OF THE PROCESS.”

Any self-respecting human being on this planet who hears or reads that quote – published in the Proceedings of the National Academy of Sciences in 2016 from a quote in 2015 at the National Academy of Sciences by Dr. Peter Daszak, the President of EcoHealth Alliance, a US-based organization that conducts research and outreach programs on global health – who says this is NOT a **BIOWEAPONS PROGRAM** that is meant to enrich the few at the expense of the general population, is absolutely DELUSIONAL.

The facts are unambiguous. We have the admission of the crime, the admission of global terrorism, the admission of murder, and NOT A SINGLE public institution has held any of these individuals accountable. AND THAT’S WITH THE EVIDENCE STRAIGHT IN FRONT OF YOUR FACE.

In 2016 – before all of the plans were formally rolled out, by violating interlocking directorates and antitrust laws on both sides of the Atlantic, the Global Preparedness Monitoring Board led by Sir Jeremy Farrar at the UK’s Wellcome Trust and supervised by Baroness Manningham-Buller, the first woman to chair the Wellcome Trust’s Board of Governors and head of MI5 – was the entity that put in place the program that said:

“By September 2020, there will be an accidental or intentional release of a respiratory pathogen so that the public will accept a global vaccine platform.”

That was first written in 2011 and recited again on 18 September 2019. This is 3.5 months BEFORE the Wuhan release, we had the Global Preparedness Monitoring Board, the Wellcome Trust, the Gates Foundation, the NIAID, the NIH, the Chinese Center for Disease Control and Prevention, and the entire cabal of the Rockefeller Foundation, all COLLUDING to accidentally or intentionally release a pathogen (you couldn't make this up), so that by September 2020, the world will accept a universal vaccine!

That is THEIR own words. It is a written, stated plan that was executed to perfection.

It was GLOBAL TERRORISM, GLOBAL GENOCIDE, for the enrichment of a few at the expense of the many. We cannot call it anything but what it is.

The wearing of MASKS did more harm than good. The hoax coronavirus was never in the air. The evidence is that the C. R. MacIntyre paper was about the only clinical trial that showed that wearing cloth face masks INCREASED influenza-like illness. Surgical face masks work the WRONG way.

We now see how EVIL the conspirators are. The nose and mouth are orifices to expel mucus, and the bad things engulfed in it, not to keep it inside our bodies.

All the above is not hearsay; it is EVIDENCE-BASED.

Today, if somebody gets the sniffles, they're told they've got Covid. We have to be clear on the fact that Covid was the brand name for the CAMPAIGN. It's not even a THING. You can't have Covid. You can't catch Covid. According to the World Health Organization's own record, it is the REBRANDING of the 11 symptoms of which you have to have 4. Every bit of the common cold, every bit of the classic influenza, and every bit of gastrointestinal nitpicking is in there. The fact of the matter is that the WHO threw all these symptoms into a basket, shook it up, and said if you have 4 of them, you have Covid.

To this day, NO ONE has been testing for the existence or absence of a pathogen, for the straightforward reason that if you did test for it, you'd find out that it wasn't there. The problem is that they are taking fragments of nucleic acid sequences and protein fragments, then saying that if those fragments exist, they might be a causative agent. But the problem is that in the early days of the 'pandemic,' an enormous number of people allegedly tested positive and had no symptoms!

So they made up the term "ASYMPTOMATIC Covid." The problem with that is, by LEGAL definition, that is DECEPTIVE MEDICAL PRACTICE, an ILLEGAL act. **You CANNOT have an asymptomatic thing that ONLY EXISTS by the PRESENCE of SYMPTOMS!**

If you don't have the symptoms, you don't have COVID-19 because COVID-19 is nothing but SYMPTOMS! You cannot spread things you don't have symptoms of.

So, this whole thing has been this mind-melding ruse to allow everybody to allegedly have Covid when the fact is that nobody has it.

There has been no one with a disease caused by an agent. There ARE people who have been sick and have died because they have had an ADMINISTRATION of an ENGINEERED INFECTIOUS REPLICATION DEFECTIVE CHIMERA derived from the coronavirus model, which was INJECTED, INSERTED, PUT IN in all kinds of distribution methods. It is THAT which is KILLING and MAIMING people.

No one died of Covid.

If you or someone you know has been jabbed, and you now have medical problems linked to the heart or nervous system, you have been infected by a BIOWEAPON. This engineered infectious replication defective substance changes the DNA in your cells. It is why the 'Covid' jabs are called mRNA jabs. They are ILLEGAL weapons of WAR.

Those who died did so through the horrific interventions and manipulations of a medical system that was covered under the BRAND Covid.

Why are so-called competent medical practitioners still reportedly saying they are treating Covid? They are treating the introduction of an ENGINEERED pathogen to harm a population. No one is treating a disease caused by an agent that happened naturally. All they are doing is dealing with the CONSEQUENCES of a sequela, an aftereffect of a disease, condition, or injury caused by the Bioweapon.

When AIDS appeared in the 1980s, chastity was heavily promoted by the depopulation monsters, but that didn't work very well. People still had sex and no amount of fearmongering about getting AIDS worked. The windfall for the morality police of the 1980s never materialized.

Similarly, this fearmongering of Covid-19 has met a problem because the uptake of the jabs and bioweapon boosters that inane governments spent billions on is not there. The number of people lining up to get the shot has nosedived.

However, although a third of the population was easily suckered into getting the jab by the hideous mainstream media controlled by the conspirators and have suffered greatly, another third was COERCED into getting them. They were put at risk by threats of losing their jobs, not getting access to places like hospitals, shops, traveling, family, etc. Coercion breaches the Nuremberg Code, so there are WAR CRIMINALS

everywhere. The England Soccer manager urged soccer players to get jabbed to save the game and return to normal. Unwittingly, he is now a war criminal because the Nuremberg Code strictly says that ignorance is not an excuse to assist in mass murder and maiming. Look at the numbers of soccer players who have died or are maimed by taking the Bioweapon.

All sports are affected.

Every publication is now showing that it is the INJECTED population that is now sick and dying. This is not a condition you catch; it is an ADMINISTERED condition.

The Cleveland/Ohio report shows that the more shots you have, the more your immune system weakens. People are getting strokes and cancers as a result of these shots lowering their immunity, so it is not just about the heart being targeted by this Bioweapon.

The actual modification of SARS Covid-2 was derived from the University of North Carolina, Chapel Hill's patent application, which was derived from the modifications done by Ralph Baric between 1999 and 2002. The thing that is now branded SARS (Severe Acute Respiratory Syndrome) comes from the 1950s coronavirus model described in the 1960s, derived from the notion of how DNA works. It was all first published in the UK, so people should consider Britain the source of the Bioweapon, funded by the Wellcome Trust. If it wasn't for the Wellcome Trust, today's global psychotic behavior might not have happened.

But the fact of the matter is that in 2023-24, '64' pathogens are being worked in the US. In 2001, just after 9/11, American people were being poisoned by Anthrax. We did not have SARS until 2003, which quickly appeared after the patenting of the INFECTIOUS REPLICATION DEFECTIVE CHIMERA in 2002. It is not natural. Nature does not go into patent offices and then goes after a bat hanging in a cave in Wuhan. UNC-Chapel Hill scientists made the Bioweapon, distributed it, and spread it worldwide. They trained scientists in Wuhan when the Gain-of-Function moratorium (suspension) was rolled out in 2013-14.

That moratorium has an INCONVENIENT truth:

The 14 October 2014 moratorium EXEMPTED UNC-Chapel Hill's Bioweapon research. What is a moratorium when you have an exemption to it? Simple. It isn't one.

This is CRIMINAL EVIDENCE. It is not an allegation but an ACCUSATION of a crime.

Everyone was suckered into believing that Tony Fauci could not do Gain-of-Function research due to this moratorium, but he carried on regardless. It was all to cover up UNC-Chapel Hill's complicity in the crime with its waver for its ENGINEERED INFECTIOUS REPLICATION DEFECTIVE CHIMERA derived from the coronavirus model.

The 2016 paper that wrote that the Wuhan coronavirus was POISED for human emergence. UNC-Chapel Hill KNEW it was breaking the law and covered it up with legal technicalities, which will be heard at a War Crimes tribunal. The paper said that the Bioweapon was READY to be DISTRIBUTED in 2016.

That fact that the world's super-rich, the 0.001 percent, increased their wealth by 50 percent during the 'plandemic' – call it what it was – can be accused of INSIDER TRADING. They had everything in place to get inane governments to splash out on their vaccines and boosters while the Nazis, communists, Satanists, and eugenicists (Bill Gates) among them began their depopulation, global warming, and digital enslavement agendas 21 and 30.

The trouble is, the moment we investigate this insider trading and take it to court, the judges are in on it and completely corrupt.
